- Only shortlisted candidates will be called for the interview. No T.A / D.A will be given to candidates called for test/interview.

- Applications without processing fee and/or processing fee submitted through Postal Order/ Bank Draft will not be considered/ accepted in any case.
- Candidates, who want to apply for more than one post, must apply separately and pay separate fee for each post.
- The experience as part time, teaching, honorary, self-employed and apprentice/ intern will NOT be considered/ counted as experience.
- Applicants serving in government/semi-government/development projects must apply through proper channel. Applicant shall submit No Objection Certificate at the time of interview, issued by the competent / appointing authority as the case may be. Applicants without NOC or old NOC will NOT be entertained.
- Decisions of Department on all matters concerning hiring, including eligibility/ short listing/ selection criteria shall be final.
