



## EXPRESSION OF INTEREST (EOI)/ PRE-QUALIFICATION



### DOCUMENT (PQD) FOR HIRING OF BUS OPERATORS FOR "PROCUREMENT, OPERATION AND MAINTENANCE OF BUSES FOR PMA SYSTEMS"

1. Punjab Masstransit Authority (PMA) is a statutory body established by the Government of the Punjab for the purposes of planning construction, operation and maintenance of mass transit systems in the major cities of the Punjab, Pakistan; for providing safe, efficient and comfortable urban transportation system.
2. Expression of Interest (EOI) is invited under PPRA Rules 2014 from firms having expertise and experience in procurement, operation and maintenance of buses. Interested firms may form joint venture with local or international firms to enhance their qualifications subject to conditions prescribed in the PQD.
3. Interested firms/JVs should include required information specified by PMA in EOI document in their submission as a pre-requisite.
4. EOI document can be downloaded from the PPRA website ([www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk)) or PMA website ([www.pma.punjab.gov.pk](http://www.pma.punjab.gov.pk)).
5. The tender fee for EOI is PKR 10,000/- (non-refundable). Only those applicants who have paid the fee shall be allowed to participate the tendering process. The tender fee can be paid through Demand Draft / Pay Order/ Cross Cheque in favor of "Metro Bus Authori Fund Account."
6. The EOIs must be dropped in Tender Box placed at the office of the Punjab Masstransit Authority, 5th Floor, Arfa Software Technology Park (ASTP), Lahore, PAKISTAN, on or before 1100 hours PST on 2nd January 2024. The EOIs will be publicly opened in the Committee Room of the Punjab Masstransit Authority, 5th Floor, Arfa Software Technology Park (ASTP), at 1130 hours PST on 2nd January 2024.
7. A Clarification meeting will take place at 1500 Hours PST on 19th December 2023 at PMA office (address given below) for the applicants who wish to attend.
8. Procurements will be carried out as per Punjab Procurement Regulatory Authority rules. Only prequalified firms shall be entitled to participate in the subsequent procurement proceedings.
9. PMA reserves the right to cancel the tendering process at any time prior to the acceptance of a proposal.
