Revenue payment shall be deposited by MMSP in PMA account in advance on quarterly basis. MMSP shall submit Revenue within Seven (07) working days at the start of each quarter. Further refer to the RFP Clause No. 12.2. In case of delay or non-payment within the stipulated date/time i.e., a notice of default shall be served. Failure to remedy the violation shall result in removal and forfeiture of the advertisement substance by the PMA, at the risk and cost of the Firm and cancellation of License. Refer to the Clause No. 19 of the RFP.3. 

